## Vacancies

We have some additional posts to fill to ensure the smooth running of Bowls Yorkshire. Do you have the skillset, time and energy to help with one of these? Do you know someone even outside the bowls community that might be willing to help?

These are new roles and the posts will develop over time with help and support from other board members and the wider bowls community in Yorkshire.

The roles are:

- \*Support officer** – to promote and protect the future of bowls in Yorkshire. At the heart of the Bowls Yorkshire's purpose is encouraging people to participate in the sport of bowls. This activity includes retaining those within the sport as well as seeing more people discovering the joy of bowls;
- \*Development officer** – to support clubs to develop, grow and be sustainable. Bowls Yorkshire looks to assist clubs with challenges they may face, including greenkeeping, managing finance, safeguarding and disciplinary matters with support from Bowls England, the Bowls Development Alliance and Bowls Yorkshire;
- \*Bowls officer** – To manage County and inter-club competitions, representative teams and other County bowling events. Each year Bowls Yorkshire manages several team events which are organised through Bowls England or the Northern Counties Bowling Association. Managing these teams and the administration that enables the games to take part is a key function of the Bowls Yorkshire. Investing in these teams is good for the benefit of bowling at all levels in Yorkshire – the publicity, exposure, the inspiration and retention of young bowlers; and for opening doors for funding/sponsorship opportunities. It also provides an opportunity for those involved to give back something to their fellow Club members in terms of the learning experience and skills developed.; and
- \*Media and Communications officer** – to manage and promote the public image of Bowls Yorkshire by creating and distributing content through the Bowls Yorkshire website, Facebook and other social media platforms; acting as a media contact point; planning events (conferences, etc); and ensuring there is consistent messaging internally and externally to build the Bowls Yorkshire brand.

## Regulation 9

All club secretaries were sent the update from Bowls England on 2 December. In a nutshell, the updated Regulation 9 is applying a proportionate approach to addressing misconduct:

- \*Informal process for minor misconduct
- \*Mediation for moderate misconduct or repeated minor issues
- \*Formal hearing for serious misconduct or failed mediation

These improvements ensure consistency, transparency, and support for everyone involved.
